

To all CMSA Certified Range Masters;

As CMSA continues to grow more opportunities arises for the Association as will as its members. Beginning November 1st of 2010 all CMSA Certified Range Masters for 2011 will have the opportunity to become an American Quarter Horse Specialty Event Judge. All CMSA Certified Range Masters who complete the following will be among those selected from for all CMSA/AQHA events held during the 2011 season.

As CMSA adds AQHA events to its schedule the need for experienced Range Masters who know the rules and regulation of both organizations will be needed to fill the AQHA specialty Judge requirements.

One important point that AQHA and CMSA want to insure that each one of you to be aware of: **If you elect to become an AQHA Specialized Judge you will lose any AQHA Amateur status and only be able to compete in the Open Class when competing in an AQHA/CMSA event.** This status has nothing to do with your level in a CMSA event or Pro Status with the CMSA.

In the near future you will find on the Range Master page of the CMSA website the following AQHA approval process. Requirements are:

1. Must be a 2011 CMSA Certified Range Master with a minimum test score of 95%.
2. Must be 25 years or older
3. Have a current AQHA individual membership in good standing – application available online.
4. Sign and submit to AQHA the AQHA Code of Ethics- form available online.
5. Complete and submit to AQHA the 10 question orientation test on rule 438 – test available online.
6. Fill out and return a biographical sheet.

The opportunity to become a AQHA card caring Judge is a privilege and is sought by many but only achieved by a few. Come be a part of the CMSA's future as we begin this exciting new venture with the American Quarter Horse Association in 2011 and become proud AQHA card caring judge.

AQHA JUDGE CODE OF ETHICS

Designation as an AQHA-approved Judge is a privilege, not a right, bestowed by the Judges Committee to individuals whose equine expertise and personal character merit the honor. It is important that you judge by and adhere to all the current rules and regulations as stated in the *AQHA Official Handbook of Rules and Regulations*. An individual's conduct as a member, exhibitor and judge, must be exemplary; is subject to continual Judge's Committee review; and such designation is revocable by the Judges Committee with or without notice and formal hearing, subject only to ultimate review by the Executive Committee.

By signing below, I agree to the following:

To uphold all rules pertaining to Judges (rule 438).

To adhere to the professional standards of the AQHA and at all times, act in a professional manner.

To be courteous and judge with a positive attitude.

To have the conviction to judge by the rules and disqualify entries that are in the violation of the rules.

To not accept any sort of remuneration, consideration, or anything of value that constitutes a bribe in the furtherance of judging duties.

To promptly report to the Director of Judges any attempt by third parties to bribe me or otherwise influence me in the furtherance of my judging services.

To report any information regarding bribes or illegal persuasion of judges, whether directed toward myself or other judges.

To ensure that the welfare of the American Quarter Horse is paramount and that every American Quarter Horse shall at all times be treated humanely and with dignity, respect and compassion.

To instill confidence among exhibitors and the public in the American Quarter Horse industry, avoiding any action conducive to discrediting it or membership in the American Quarter Horse Association.

To judge honestly, fairly and impartially each horse exhibited to me strictly on the horse's conformation and/or its performance as the rules of the event dictate.
